

Licence No: 30/OFF/1295/2022

PURSUANT to the Sale and Supply of Alcohol Act 2012 (the Act), and the **Endorsement** to section 40, **RIVERBEND ROAD WINES LIMITED** (the licensee) is authorised to sell alcohol by remote sale from (but not on) the premises situated at **288 Riverbend Road Meeanee, Napier** and known as **Riverbend Road Wines Limited**, to any person for consumption off the premises and to deliver it or have it delivered by some other person somewhere else.

Pursuant to s215 of the Act the authority conferred by this licence need not be exercised through a manager appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act at all times.

CONDITIONS

The licence is subject to the following conditions:

- a. Alcohol may be sold:

Any hour of any day

- b. No alcohol is to be **delivered** on:

**Good Friday, Easter Sunday, Christmas Day or before 1:00pm on Anzac Day, nor:
At any time after 11:00pm on any day and before 6:00am on the next day.**

- c. Pursuant to Regulations 14 and 15 of the Sale and Supply of Alcohol Regulations 2013:

- i. The licensee must take reasonable steps to verify that the buyer of any alcohol that the holder sells by remote sale (and, if a person other than the buyer is to receive it, to verify that the receiver) is not under the purchase age.
- ii. The licensee when selling alcohol by remote sale via the internet must comply with any regulations made under the Act requiring information to be visible on the holder's website when people browse, enter, or otherwise access it.
- iii. The licensee when selling alcohol by remote sale by mail order must comply with any regulations made under the Act requiring information to be published in the holder's catalogues.
- iv. The licensee when selling alcohol by remote sale by telephone must comply with any regulations made under the Act requiring information to be given to callers.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the renewal, suspension and cancellation of licences, this licence expires on:

16th day of September 2025

Notice of Renewal of Licence

The off licence in respect of the premises situated at **288 Riverbend Road Meeanee, Napier** and known as **Riverbend Road Wines Limited**, is renewed.
